- ◆ Announcements and information are posted on the community website, such as the community guidelines and vehicle registration form.

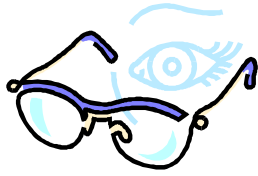
UPDATES ON COMMUNITY INITIATIVES

- **Repaving and Painting:** The Board and NVM have been working to address concerns related to work performed in the fall of 2005. Work began on Sept. 20th when NVM edge milled and repaved sections of road through out the community. Remaining work includes resealing and

restriping the roads, redoing select speed bumps, as well as power wash and repaint the curbs. All work should be completed by the end of October 2006.

- **Neighborhood Watch:** On Aug. 29, 2006, a training session was held to get a program up and running in Westhaven. Signs near

NEIGHBORHOOD WATCH IN WESTHAVEN

Recent incidents in the neighborhood have served as a catalyst for getting Neighborhood Watch started in Westhaven.

On August 29, 2006, several residents attended a training session which will qualify the neighborhood to post Neighborhood Watch signs at each entrance of the community.

The training session offered useful tips for observing and

reporting suspicious activity in the neighborhood. Other suggestions noted are:

- Keep outside porch and street lights on at night.
- Keep doors locked, even while you are at home.
- Have your newspaper delivery suspended while you are out of town.
- Be observant of your surroundings.

Please report any suspicious persons or events to the local authorities. If you notice any damage to the community or problems that need to be addressed in future board meetings, please contact the property management company.

With your assistance, we can watch out for each other and keep our neighborhood safe.

Landscaping Projects: A portion of the Special Assessment collected in 2005 was allocated for select landscaping projects throughout the community. These projects have been completed.

Other landscaping initiatives before year end:

- Remove several dead trees in the neighborhood

- Prune oak trees in the park area and at the front of the east entrance
- Address drainage problem near the sidewalk along the street at the park area.
- Replace damaged/fading stop and speed limit signs
- Make plan for work to be done next spring.

Architectural Review: Many thanks for the efforts to complete the annual architectural review process. Several homeowners have already taken steps to maintain and improve their properties.

Spring Fling: Thanks to those who volunteered and participated in this year's Spring Fling in May. The Social Committee is already thinking about next year's event.

- **Parking:** Please park your vehicles in your garages or on your driveways/assigned spaces. We have a chronic problem of residents parking in the limited number of visitor spaces. Parking rules will be more strictly enforced in the upcoming months. Therefore, your vehicles should display the appropriate parking decal issued by the community to avoid towing. - **Putting Trash Out:** Trash should only be put out after 7pm on Sunday and Wednesday evenings. Recycling is put out on Wednesday evenings.
- **Pets:** Please be sure to carry a bag with you while walking your pet to dispose of any waste. Also, all pets should be on a leash. *These neighborhood requirements are also the law in Fairfax County.*
